Intake Therapist Job Duties:

- Establish an environment of support for new clients.
- Obtain a comprehensive psychosocial history.
- Diagnose and provide treatment recommendations.
- Ensure clients are appropriately assigned to ongoing agency programming.
- Monthly team meetings and client updates

CLINICAL SUPERVISOR (LISW, LISW-S, LPCC, LPCC-S)

Thrive Holistic Counseling & Therapy Center has a very attractive supervisory role for a full-time Clinical Supervisor to lead our small team of therapists and case managers. The Clinical Supervisor will provide daily guidance as well as individual and group supervision to the clinical team. The Clinical Supervisor may also be expected to provide some clinical services including assessment, individual and group therapy, and crisis intervention.

Essential Duties and Responsibilities

- Provide and document individual and group supervision for all clinical team members. Conduct yearly staff evaluations.
- Ensure quality and timeliness of clinical documentation.
- Coordinate with QI to ensure documentation compliance.
- Manage productivity standards of the clinical team.
- Work closely with the Director to support the needs of clients and facilities.
- Ensure complete assessments on all client/families applying eligibility and diagnostic criteria to determine client appropriateness for treatment in various modalities.
- Facilitate individual, group and family counseling, facilitates client and family groups and programs, and facilitates other groups as assigned.
- Provide crisis intervention and risk assessments as needed.
- Collaborate and maintain positive working relationships with placement sources and other stakeholders.
- Develop specific treatment goals in collaboration with client, client's guardian, and client's treatment providers.
- Identify and evaluate client's strengths, limitations, problems and needs and include these in client ISP (individual service plan).
- Collaborate with the treatment team to develop, implement and modify the ISP (individual service plan) as required.
- Participate in a treatment team to provide updates on client progress in group, individual and family counseling.
- Complete treatment plans and all required documentation; submit as required.
- Provide case management/community psychiatric supportive treatment (CPST).
- Meet productivity requirements.
- Provide a variety of counseling services to address the specific needs of the population served. Skilled in working with clients with multiple issues: trauma, addiction, mental health, grief and loss, etc.
- Utilize evidence-based treatment to ensure effective service delivery based on client's clinical issues/needs.
- Provide information and guidance on utilization of community resources, initiates and follows up on referrals as needed.

- Chart results of assessment and treatment planning; writes reports, progress notes, discharge summaries and other client-related information in support of client's progress in treatment in a timely manner.
- Participate actively in both group and 1-1 therapist supervision processes to ensure comprehensive, quality care for clients.
- Participate in professional development by attending workshops, seminars and classes in job related areas.
- Comply with all federal, state and funding regulatory requirements.
- Performing other related activities as assigned.

- Master's degree in counseling or social work with at least 1-year supervisory experience.
- Strong interpersonal and communication skills and the ability to work. effectively with a wide range of individuals in a diverse community, both internally and externally.

- Must always have and exercise good personal and professional boundaries.
- Strong decision-making skills, demonstrating sound judgment.
